- **Structure & Classification:**
Chiratae Ventures International Fund V (the “Gift Fund”), established as a trust constituted under the Indian Trusts Act, 1882.

The Gift Fund is a Restricted Scheme (non-retail) construed as Category II AIF under IFSCA (FM) Regulations with a tenure of 10 years from the initial closing which is further extendable by 2 years.
- **Investment Strategy**

The Gift Fund seeks to make investments primarily in technology and technology enabled companies in India (“India Investments”) and in other jurisdictions (“Offshore Investments”).

The Gift Fund will make India Investment through Chiratae Ventures Master Fund V (“Indian Master Fund”), a scheme of Chiratae Trust V II and Offshore Investment directly.
